POLICY FOR COPYING FROM BOOKS, JOURNALS, PERIODICALS AND TELEVISION/FILM RECORDINGS

- 1.0 Trust schools are licensed with The Copyright Licensing Agency (Ltd), subject to terms and conditions, that permits the copying and re-use of extracts of text and still images from printed books, journals and magazines, and from digital publications (including websites that are free-to-view but not free-to-copy).
- 1.1 Full details of what the Licence covers is displayed adjacent to all photocopiers in schools so that staff can easily identify what is covered and associated extent limits. Administration staff within Reprographics facilities are also aware of the Licence and checks are made for compliance.
- 1.2 The latest versions of the Licence are always referred to. As updates are provided, they are circulated to staff and displayed appropriately.
- 1.3 Requisition forms that staff complete when ordering copies to be made specifies the restrictions and refers staff to the full Licence to ensure compliance.
- 1.4 The use of AI must not infringe copyrighted material in any form.

2.0 **TELEVISION RECORDINGS**

All television programme recordings must be taken and be properly labelled in accordance with the Educational Recording Agency Licence. In order to comply with the Licence regulations all recordings must be marked with the date and title of the recording and with a statement in clear and bold lettering that "this recording is to be used only for educational purposes". The ERA does inspect schools from time to time to check that the terms of the licence are being complied with.

3.0 **FILMS**

Under UK copyright law, schools wishing to play a film in public generally require a licence from the copyright owner or its representatives before doing so. 'In public' means to an audience outside of the home. If the school does not obtain the required licence there is the risk of infringing copyright. With this in mind, every quarter, schools have to let Filmbank Distributors Limited know which films have been screened under the Public Video Screening Licence in the preceding 3 months.
